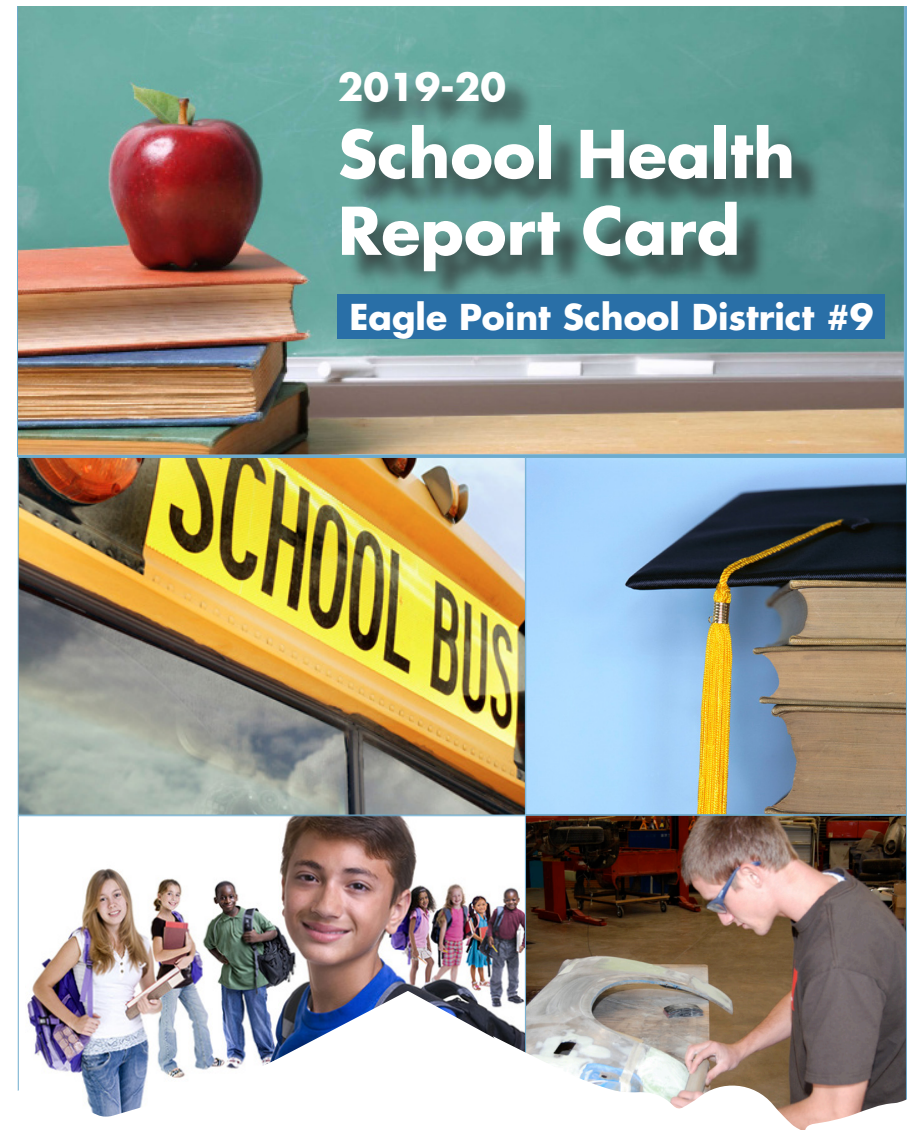

While intended to keep students safe during the COVID-19 pandemic, school closures ushered in a different set of dangers for some students: anxiety, depression and other serious mental health conditions. Staying in contact with students was a priority; however, we did experience challenges. Lack of telephone/internet service as well as outdated cell numbers lead to mailing letters to students, which slowed communications; plus some students were not interested in telehealth conversations. Students shared with counselors about their newly unemployed parents, that they felt they were falling behind academically, couldn't see their friends, and a few felt trapped at home in an abusive family situation.
