OPERATIONAL BLUEPRINT FOR SCHOOL REENTRY 2020-21

Updated 2/12/2021

Under ODE's Ready Schools, Safe Learners guidance, each school¹ has been directed to submit a plan to the district² in order to provide on-site and/or hybrid instruction. Districts must submit each school's plan to the local school board and make the plans available to the public. This form is to be used to document a district's, school's or program's plan to ensure students can return for the 2020-21 school year, in some form, in accordance with Executive Order 20-25(10). Schools must use the *Ready Schools, Safe Learners* guidance document as they complete their Operational Blueprint for Reentry. ODE recommends plan development be inclusive of, but not limited to, school-based administrators, teachers and school staff, health and nursing staff, association leadership, nutrition services, transportation services, tribal consultation, a parents and others for purposes of providing expertise, developing broad understanding of the health protocols and carrying out plan implementation. It is required that a revised Operational Blueprint be completed and updated when there is a change of Instructional Model.

Our staff and District held a number of listening sessions with parents/families, certified and classified staff regarding reopening. We sent (3) surveys to parents and surveyed staff that asked a variety of questions. Parent Q & A sessions were held via Facebook Live events (In English and Spanish) and these were regularly posted on our district website and social media. A Town Hall Meeting was held for both the community and staff. An email address has been created for families to email their questions to us. The district has also setup a digital suggestion box for ideas, concerns and feedback. We have shared our blueprints with our SCS Leadership team and all SCS staff, asking for feedback. The district has requested Tribal consultation.

1. Public Health Protocols

1a. COMMUNICABLE DISEASE MANAGEMENT PLAN FOR COVID-19

OHA/ODE Requirements

- Conduct a risk assessment as required by OSHA administrative rule OAR 437-001-0744(3)(g).
 - OSHA has developed a <u>risk assessment template</u>.
- Update written Communicable Disease Management Plan to specifically address the prevention of the spread of COVID-19. Examples are located in the <u>Oregon School Nurses Association</u> (OSNA) COVID-19 Toolkit.
 - Review OSHA requirements for infection control plan to ensure that all required elements are covered by your communicable disease management plan, including making the plan available to employees at their workplace.
 Requirements are listed in OSHA administrative rule OAR 437-001-0744(3)(h).
 - OSHA has developed a sample infection control plan.
- Designate a single point-person at each school to establish, implement, support and enforce all RSSL health and safety protocols, including face coverings and physical distancing requirements, consistent with the *Ready Schools, Safe Learners* guidance and other guidance from OHA. This role should be known to all staff in the building with consistent ways for licensed and classified staff to access and voice concerns or needs.
- Create a simple process that allows for named and anonymous sharing of concerns that can be reviewed on a daily and weekly basis by the designated RSSL building point-person. - Plans for systematic disinfection of classrooms, common areas, offices, table surfaces, bathrooms and activity areas.
- Process to report to the LPHA any cluster of any illness among staff or students.

Hybrid/Onsite Plan

- Our EPSD 9 District Office has conducted a risk assessment.
- Eagle Point School District 9 schools follow the published Communicable Disease Guidance from the Oregon Department of Education and the Oregon Health Authority.
- EPSD9 schools also follow our district's Communicable Disease Plan
- EPSD9 schools follow School Board Policies GBEB, GBEB-AR, JHCC, IHCC-AR
- EPSD9 schools work closely with the Local Public Health Authority (LHA) Jackson County Health and Human Services to coordinate and consult when making decisions.
- Visual screening of all students and staff is outlined in 1f.
- Potentially symptomatic students will be isolated following guidance outlined in 1i.
- EPSD9's and our Prevention and Planning, Response, and Recovery and Reentry Protocols are outlined in sections 3a, 3b, and 3c.
- Systematic disinfection of our school spaces will occur and is outlined in sections 2h, 2j, and 3c.
- Contract tracing logs will be maintained and will be kept for a minimum of four weeks at our site to assist the LHA as needed for each student and each cohort as is outlined in sections 1i, 2e, and 2i.
- All itinerant and all district staff (maintenance, administrative, delivery, nutrition, and any other staff) who move between buildings will keep a log or calendar with a running four-week history of their time in each school building and who they were in contact with at each site to assist the LHA as needed for each student and each cohort as is outlined in sections 1i, 2e, and 2i.
- Principal Isackson will establish, implement, and enforce physical distancing requirements, consistent with this guidance and other guidance from OHA.
- •Staff will be able to voice concerns to Principal Isackson and a digital anonymous form will be available to staff to share concerns.
- Medical staff providing support and resources to the district's and our school's policies and planning include Deborah Hornbacher, BSN, RN (EPSD9 nurse), and Terry Keesling, Chief Operation Officer at Rogue Community Health. Our plan follows the ongoing guidance from Jackson County Health and Human Services, and will be submitted to Jackson County Public Health, our LHA.
- Protocol has been established and shared with staff for screening of staff and student's entry. We use the Illness Protocol flow chart as well as our school's <u>Entry Screening and Classroom Procedures</u> <u>Protocol.</u>
- Each staff member will check in to each area of the school they enter for the purpose of contact tracing. Students contact tracing will take place through our student information system. Each student will log in and out of the classroom when leaving for restroom, office, library, etc...If a student is in another smaller cohort their attendance will also be logged. This may be done digitally or paper copy.

- Protocol to isolate any ill or exposed persons from physical contact with others.
- Protocol for communicating potential COVID-19 cases to the school community and other stakeholders (see section 1e of the Ready Schools, Safe Learners guidance).
- Create a system for maintaining daily logs for each student/cohort for the purposes of contact tracing. This system needs to be made in consultation with a school/district nurse or an LPHA official. Sample logs are available as a part of the <u>Oregon School Nurses</u> <u>Association COVID-19 Toolkit</u>.
 - If a student(s) is part of a stable cohort (a group of students that are consistently in contact with each other or in multiple cohort groups) that conform to the requirements of cohorting (see section 1d of the *Ready Schools, Safe Learners* guidance), the daily log may be maintained for the cohort.
 - If a student(s) is not part of a stable cohort, then an individual student log must be maintained.
- Required components of individual daily student/cohort logs include:
 - Child's name
 - Drop off/pick up time
 - Parent/guardian name and emergency contact information
 - All staff (including itinerant staff, district staff, substitutes, and guest teachers) names and phone numbers who interact with a stable cohort or individual student
- Protocol to record/keep daily logs to be used for contact tracing for a minimum of four weeks to assist the LPHA as needed.
 - See supplemental guidance on LPHA/school partnering on contact tracing.
 - Refer to OHA Policy on Sharing COVID-19 Information
- Process to ensure that all itinerant and all district staff (maintenance, administrative, delivery, nutrition, and any other staff) who move between buildings keep a log or calendar with a running four-week history of their time in each school building and who they were in contact with at each site.
- Process to ensure that the school reports to and consults with the LPHA regarding cleaning and possible classroom or program closure if anyone who has entered school is diagnosed with COVID-19.
- Designate a staff member and process to ensure that the school provides updated information regarding current instructional models and student counts and reports these data in <u>ODE's COVID-</u> 19 Weekly School Status system.
- Protocol to respond to potential outbreaks (see section 3 of the Ready Schools, Safe Learners guidance).

Hybrid/Onsite Plan

- Our staff has been trained on health protocols and will continue training throughout the school year.
- During in-service weeks and prior to on-site learning Principal Isackson reviewed sections 1-3 ODE Ready Schools, Safe Learners guidance and Schools Operational Blueprint.
- Custodial team will disinfect classrooms, office spaces, bathrooms daily, and high touch areas throughout the school day; Each cohort will have their own equipment bag and will be disinfected at the end of each day. (section 2g); Cafeteria tables will be disinfected between cohort use.
- Principal Isackson or designee will report weekly School Status updates to the state.
- •Our staff will follow the protocol in response to potential outbreaks (see section 3 of the *Ready Schools, Safe Learners* guidance).
- •Our staff will report to and consult with the COVID Response Team. They report and consult with the LPHA regarding cleaning and possible classroom or program closure if anyone who has entered school is diagnosed with COVID-19.

1b. HIGH-RISK POPULATIONS

OHA/ODE Requirements

Serve students in high-risk population(s) whether learning is happening through On-Site (including outside), Hybrid (partially On-Site and partially Comprehensive Distance Learning models), or Comprehensive Distance Learning models.

Medically Fragile, Complex and Nursing-Dependent Student Requirements

All districts must account for students who have health conditions that require additional nursing services. Oregon law (ORS 336.201) defines three levels of severity related to required nursing services:

Hybrid/Onsite Plan

All staff and students' families have been given the opportunity to self-identify as medically vulnerable or living with a vulnerable staff member. We will serve students in high-risk population(s) whether learning is happening through On-site, Hybrid or Comprehensive Learning models.

Students

 All students identified as vulnerable, either by a physician, or parent/guardian notification, or if requested by parents/guardians, will be enrolled in off-site only learning with

- Medically Complex: Are students who may have an unstable health condition and who may require daily professional nursing services.
- Medically Fragile: Are students who may have a lifethreatening health condition and who may require immediate professional nursing services.
- Nursing-Dependent: Are students who have an unstable or life-threatening health condition and who require daily, direct, and continuous professional nursing services.
- Review <u>Supplemental Guidance on Community and Health</u> <u>Responsibilities Regarding FAPE in Relation to IDEA During CDL and</u> Hybrid.
- Staff and school administrators, in partnership with school nurses, or other school health providers, should work with interdisciplinary teams to address individual student needs. The school registered nurse (RN) is responsible for nursing care provided to individual students as outlined in ODE guidance and state law:
 - Communicate with parents and health care providers to determine return to school status and current needs of the student
 - Coordinate and update other health services the student may be receiving in addition to nursing services. This may include speech language pathology, occupational therapy, physical therapy, as well as behavioral and mental health services.
 - Modify Health Management Plans, Care Plans, IEPs, or 504 or other student-level medical plans, as indicated, to address current health care considerations.
 - The RN practicing in the school setting should be supported to remain up to date on current guidelines and access professional support such as evidence-based resources from the Oregon School Nurses Association.
 - Service provision should consider health and safety as well as legal standards.
 - Appropriate medical-grade personal protective equipment (PPE) should be made available to <u>nurses and other health</u> providers.
 - Work with an interdisciplinary team to meet requirements of ADA and FAPE.
 - High-risk individuals may meet criteria for exclusion during a local health crisis.
 - Refer to updated state and national guidance and resources such as:
 - U.S. Department of Education Supplemental Fact Sheet: Addressing the Risk of COVID-19 in Preschool, Elementary and Secondary Schools While Serving Children with Disabilities from March 21, 2020.
 - ODE guidance updates for Special Education.
 Example from March 11, 2020.
 - OAR 581-015-2000 Special Education, requires districts to provide 'school health services and school nurse services' as part of the 'related services' in order 'to assist a child with a disability to benefit from special education.'
 - OAR 333-019-0010 Public Health: Investigation and Control of Diseases: General Powers and Responsibilities, outlines authority and responsibilities for school exclusion.

Hybrid/Onsite Plan

virtual check-ins with a licensed teacher.

- Students who experience disability will continue to receive specially designed instruction.
- Reviewed <u>Supplemental Guidance on Community and Health</u>
 Responsibilities Regarding FAPE in Relation to IDEA During CDL and
 Hybrid.
- Students with language services will continue to receive English Language Development.
- Our Staff and school administrators, in partnership with the school nurse, will work with interdisciplinary teams to address individual student needs.

1c. PHYSICAL DISTANCING

OHA/ODE Requirements

- Establish a minimum of 35 square feet per person when determining room capacity. Calculate only with usable classroom space, understanding that desks and room set-up will require **use of all space** in the calculation. This also applies for professional development and staff gatherings. If implementing Learning Outside guidance, establish an outside learning space for learning that maintains minimum 35 square feet per person.
 - Within this design, educators should have their own minimum of 35 square feet and the design of the learning environment must allow for some ability for the educator to move through the room efficiently and carefully without breaking 6 feet of physical distance to the maximum extent feasible.
- Support physical distancing in all daily activities and instruction, maintaining six feet between individuals to the maximum extent possible.
- Minimize time standing in lines and take steps to ensure that six feet of distance between students is maintained, including marking spacing on floor, one-way traffic flow in constrained spaces, etc.
- Schedule modifications to limit the number of students in the building or outside learning space (e.g., rotating groups by days or location, staggered schedules to avoid hallway crowding and gathering).
- Plan for students who will need additional support in learning how to maintain physical distancing requirements. Provide instruction; don't employ punitive discipline.
- Staff must maintain physical distancing during all staff meetings and conferences, or consider remote web-based meetings.

Hybrid/Onsite Plan

- Classroom capacity has been determined by establishing a minimum of 35 square feet per person in each learning space. This standard also applies for professional development and staff gatherings. Each classroom has physical markings to address this requirement.
- Extra furniture has been removed and stored to make as much usable space within the classroom and common learning spaces.
- Seating will be assigned to maximize physical distancing and minimize physical interaction.
- Expected physical distancing requirements will be taught and re-taught as needed using age-appropriate methods.
- Physical distancing in all daily activities and instruction will be supported, striving to maintain at least six feet between individuals whenever possible.
- Classrooms, hallways, and other spaces will have visual cues (e.g., floor decals, colored tape or signs) to illustrate traffic flow, appropriate six feet spacing, and seating areas.
- Time standing in lines will be minimized.
- We have added schedule modifications such as staggered start and end times, staggered mealtimes, etc. as one way to limit the number of students in the building or in an area at one time. (see 2e)
- Staff should maintain physical distancing during all staff meetings and conferences or meet remotely with web-based meetings. Majority of staff meetings will take place virtually. Staff shall also not congregate together for breaks or meals.

1d. COHORTING

OHA/ODE Requirements

- Where feasible, establish stable cohorts: groups shall be no larger than can be accommodated by the space available to provide 35 square feet per person, including staff.
 - The smaller the cohort, the less risk of spreading disease. As cohort groups increase in size, the risk of spreading disease increases
- Students cannot be part of any single cohort, or part of multiple cohorts that exceed a total of 100 people within the educational week⁴, unless the school is offering Learning Outside, then they must follow guidelines for cohorting in Learning Outside guidance. Schools must plan to limit cohort sizes to allow for efficient contact-tracing and minimal risk for exposure. Cohorts may change week-to-week, but must be stable within the educational week.
- Each school must have a system for daily logs to ensure contract tracing among the cohort (see section 1a of the *Ready Schools*, *Safe Learners* guidance).
- Minimize interaction between students in different stable cohorts (e.g., access to restrooms, activities, common areas). Provide access to All Gender/Gender Neutral restrooms.
- Cleaning and sanitizing surfaces (e.g., desks, dry erase boards, door handles, etc.) must be maintained between multiple student uses, even in the same cohort.

Hybrid/Onsite Plan

Daily Logs

• Staff assigned to each classroom will maintain a daily sign-in log (our Student Information System) documenting each student who enters for the purpose of contact tracing (see section 2e Logs for Contact Tracing) and will screen for symptoms. Each classroom will keep a daily log of entry and exits into the classroom.

Cleaning and Hygiene

- All frequently touched surfaces (e.g., playground equipment, door handles, sink handles, transport vehicles) and shared objects (e.g., toys, games, art supplies) will be cleaned between multiple student uses, even in the same cohort.
- Drinking fountains are covered and students will provide their own refillable water bottle and/or water will be provided for them.
- Staff who interact with multiple stable cohorts must wash/sanitize their hands between interactions with different stable cohorts.
- Shared objects will be limited as much as possible and cleaned between uses.
- We have an increase in hand hygiene practices with scheduled times throughout the day for students to wash with soap and water or utilize hand sanitizer.

⁴ The cohort limit is focused on the students experience and their limit of 100 people includes every person they come into contact with, including staff. There is not a limitation for staff in cohort size while care should be given to design and attention to the additional requirements.

- Design cohorts such that all students (including those protected under ADA and IDEA) maintain access to general education, gradelevel academic content standards⁵, and peers.
- Minimize the number of staff that interact with each cohort to the extent possible, staff who interact with multiple stable cohorts must wash/sanitize their hands between interactions with different stable cohorts.
- Elementary staff who interact with multiple cohorts (music, PE, library, paraprofessionals who provide supervision at recesses, etc.) should have schedules altered to reduce the number of cohorts/students they interact within a week. Consider having these staff engage via technology, altering duties so that they are not in close contact with students in multiple cohorts, or adjust schedules to reduce contacts.

Hybrid/Onsite Plan

- Hands are washed with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60%-95% alcohol-based hand sanitizer before meals and encouraged to do so after; hand sanitizer can be used at all other times except hands must be washed with soap and water for 20 seconds after the bathroom
- Staff meetings and professional development will be held in a room where a minimum of 35 square feet per person is available or will be conducted remotely.
- Staff will regularly wipe down surface areas as student's transition between cohorts.
- All staff who interact with multiple stable cohorts must wash/sanitize their hands between interactions with different stable cohorts.

Cohorts

- Students are not a part of any single cohort, or part of multiple cohorts that exceed a total of 100 student contacts within the educational week.
- SCS limits cohort sizes to allow for efficient contact-tracing and minimal risk for exposure.
- SCS minimizes interaction between students in different stable cohorts by scheduling student access to common areas. (e.g., access to restrooms, activities, common areas).
- K-8 grade level cohorts are maintained throughout the year and for each specialized area (special education support, English Language Development, music, PE, etc.)

Kindergarten (KG) and 1st Grade Classrooms

- Total of two classes (one KG and one 1st Grade). One teacher will teach math the other ELA and teachers will switch classrooms while students stay in the same.
- Square Footage of the classrooms support physical distancing.
- Develop Class Roster with no more than 36 (maximum of 40 people per 1431 ft2 classroom ITEC)
- Develop Class Roster with no more than 18 (maximum of 20 people per 703 ft2 classroom PD)
- The Kindergarten class will be supported by an Instructional Assistant (IAs), to provide instructional support and in order to support/encourage physical distancing. An additional IA will push in throughout the day to provide additional support to both classrooms.

1st/2nd Grade Split and 2nd Grade Classrooms

- Develop class rosters to have no more than 21 students with one teacher in the 1st/2nd (maximum of 23 people per 810 ft2 classroom Rm 9).
- Develop class rosters to have no more than 22 students with one teacher in the 2nd (maximum of 23 people per 855 ft2 classroom Rm 10)
- Depending on the number of students that day an IA will provide push in or pull-out support.

3rd Grade-3rd/4th Grade Classrooms

• Develop class rosters to have no more than 23 students with one teacher in the 3rd grade (maximum of 25 people per 893.75 ft2 classroom Rm 6).

⁵ Academic content standards refer to all of Oregon state academic standards and the Oregon CTE skill sets.

OHA/ODE Requirements Hybrid/Onsite Plan • Develop class rosters to have no more than 22 students with one teacher in the 3rd/4th grade (maximum of 24 people per 855 ft2 classroom Rm 8). • Depending on the number of students that day an IA will provide push in or pull-out support. 4th - 5th Grade Classrooms • Develop class rosters to have no more than 22 students with one teacher in the 4th grade (maximum of 24 people per 855 ft2 classroom Rm 1 plus potential of 21 additional people in Rm 2 of 832.5 • Develop class rosters to have no more than 22 students with one teacher in the 5th grade (maximum of 23 people per 832 ft2 classroom Rm 2). If the roster has more than 22 students, we will use the additional office space of and additional 35 sq ft. 1e. PUBLIC HEALTH COMMUNICATION AND TRAINING

OHA/ODE Requirements

- Communicate to staff at the start of On-Site instruction and at periodic intervals explaining infection control measures that are being implemented to prevent spread of disease.
- Offer initial training to all staff prior to being in-person in any instructional model. Training could be accomplished through all staff webinar, narrated slide decks, online video, using professional learning communities, or mailing handouts with discussion. Training cannot be delivered solely through the sharing or forwarding information electronically or in paper copy form as this is an insufficient method for ensuring fidelity to public health protocols (see section 8b of the Ready Schools, Safe Learners guidance for specific training requirements). Note: Instructional time requirements allow for time to be devoted for professional learning that includes RSSL training.
- Post "COVID -19 Hazard Poster" and "Masks Required" signs as required by OSHA administrative rule OAR 437-001-0744(3)(d) and (e).
- Develop protocols for communicating with students, families and staff who have come into close contact with a person who has COVID-19.
 - The definition of exposure is being within 6 feet of a person who has COVID-19 for at least 15 cumulative minutes in a day.
 - OSHA has developed a <u>model notification policy</u>.
- Develop protocols for communicating immediately with staff, families, and the school community when a new case(s) of COVID-19 is diagnosed in students or staff members, including a description of how the school or district is responding.
- Periodic interval training also keeps the vigilance to protocols ever present when fatigue and changing circumstances might result in reduced adherence to guidance.
- Provide all information in languages and formats accessible to the school community.

Hybrid/Onsite Plan

- •The District COVID Response Team communicated the infection control measures that are being implemented to prevent the spread of the disease.
- Disease control measures will continue to be shared throughout the year in periodic intervals.
- All staff will have gone through COVID training prior to the opening of in-person instruction. This training was provided by the district through the frontline portal. Training will continue throughout the year and protocols will be shared digitally in staff meetings, newsletters and emails.
- Safety COVID 19 hazard posters will be posted around the school such as mask requirements and how to properly wash your hands.
- The District COVID Response Team will develop protocols for communicating with students, families, and staff addressing:
 - What to do if you suspect you or your family members may be symptomatic?
 - What to do if in close/sustained contact with a confirmed case? The definition of exposure is being within 6 feet of a COVID-19 case for 15 minutes (or longer).
 - How does the district respond when a new case has been confirmed?
- Updated communication will be shared with families and staff at least monthly or as updated information is available.
- Protocols and information will be available on the EPSD9 and our school's website.
- Information will be made available in languages and formats accessible to the school community.

1f. ENTRY AND SCREENING

OHA/ODE Requirements

- ☑ Direct students and staff to stay home if they have COVID-19 symptoms. COVID-19 symptoms are as follows:
 - Primary symptoms of concern: cough, fever (temperature of 100.4°F or higher) or chills, shortness of breath, difficulty breathing, or new loss of taste or smell.
 - Note that muscle pain, headache, sore throat, diarrhea, nausea, vomiting, new nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available <u>from</u> CDC.
 - In addition to COVID-19 symptoms, students must be excluded from school for signs of other infectious diseases,

Hybrid/Onsite Plan

Screening on Entry

- Students and staff are directed to stay home if they, or anyone in their homes or community living spaces, has COVID-19.
- SCS will follow the LPHA's advice on restricting any student or staff known to have been exposed (e.g., by a household member) to COVID-19 and following our districts COVID 19 Illness Protocol or doctor recommendation.
- Staff are required to report to their supervisor when they may have been exposed to COVID-19 or have symptoms related to COVID-19.
- All students will be visually screened for symptoms on entry to bus and school buildings every day.

per existing school policy and protocols. See pages 9-11 of OHA/ODE Communicable Disease Guidance for Schools.

- Emergency signs that require immediate medical attention:
 - Trouble breathing
 - Persistent pain or pressure in the chest
 - New confusion or inability to awaken
 - Bluish lips or face (lighter skin); greyish lips or face (darker skin)
 - o Other severe symptoms
- Diligently screen all students and staff for symptoms on entry to bus/school/outside learning space every day. This can be done visually as well as asking students and staff about any new symptoms or close contact with someone with COVID-19. For students, confirmation from a parent/caregiver or guardian can also be appropriate. Staff members can self-screen and attest to their own health, but regular reminders of the importance of daily screening must be provided to staff.
 - Anyone displaying or reporting the primary symptoms of concern must be isolated (see section 1i of the *Ready Schools, Safe Learners* guidance) and sent home as soon as possible. <u>See table "Planning for COVID-19 Scenarios in</u> Schools."
 - Additional guidance for nurses and health staff.
- ☑ Follow LPHA advice on restricting from school any student or staff known to have been exposed (e.g., by a household member) to COVID-19. See "Planning for COVID-19 Scenarios in Schools" and the COVID-19 Exclusion Summary Guide.
- Staff or students with a chronic or baseline cough that has worsened or is not well-controlled with medication must be excluded from school. Do not exclude staff or students who have other symptoms that are chronic or baseline symptoms (e.g., asthma, allergies, etc.) from school. See the COVID-19 Exclusion Summary Guide.
- Hand hygiene on entry to school every day: wash with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol.

Hybrid/Onsite Plan

- Parents will be asked to report actual symptoms when calling in students sick as part of communicable disease surveillance.
- Transportation specific screening protocols will be followed (see section 2i).
- Staff will not screen other staff.

Screening Students

- All classrooms will utilize the outside wing doors for entrance, except for 8th grade;
- The classroom teacher or instructional assistant will conduct a visual screen for the appearance of symptoms as they enter campus and classroom. Student temperatures will be taken in the first 10 minutes they enter the classroom. Staff will follow the EPSD9 COVID 19 Illness Protocol and our SCS Entry, Screening and Classroom Procedure Protocol

Hand Hygiene on Entry

- All people entering the building shall wash or sanitize hands on entry to school buildings every day.
- Handwashing stations or hand sanitizer dispensers will be placed by each entrance prior to student entrance to classes, or students will utilize classroom stations to wash hands.

Symptomatic Staff and Students

- Anyone displaying or reporting the primary symptoms of concern must be isolated and sent home as soon as possible (see section 1i of the *Ready Schools, Safe Learners* guidance). They must remain home following our districts COVID 19 Illness Protocol or doctor recommendation.
- Staff or students with a chronic or baseline cough that has worsened or is not well-controlled with medication should be excluded from school.

Existing Conditions

 We will not exclude staff or students who have a cough that is not a new onset or worsening cough (e.g., asthma, allergies, etc.) from school.

Ongoing Communication

- Families will be reminded weekly to report actual symptoms when calling students in sick as part of communicable disease surveillance
- Any student or staff known to have been exposed (e.g., by a household member) to COVID-19 shall not be allowed on campus until the passage of 10 calendar days after exposure and until symptoms (e.g., fever, cough, shortness of breath, sore throat, headache) are improving.

1g. VISITORS/VOLUNTEERS

OHA/ODE Requirements

- Restrict non-essential visitors/volunteers.
 - Examples of essential visitors include: DHS Child Protective Services, Law Enforcement, etc.
 - Examples of non-essential visitors/volunteers include: Parent Teacher Association (PTA), classroom volunteers, etc.
- Diligently screen all visitors/volunteers for symptoms and ask questions about symptoms and any close contact with someone diagnosed with COVID-19 upon every entry. Restrict from school

Hybrid/Onsite Plan

- Non-essential visitors/volunteers will be unable to work at SCS, or complete other volunteer activities that require in-building interaction, at this time.
- Adult visitors in schools are limited to essential personnel (service providers, contractors, ESD personnel, RPP Program volunteers, Grandparents Program, etc.) only.
- All visitors will check-in at the front office and will be visually screened for COVID 19 Symptoms. They will also be asked about any symptoms they are experiencing and if they have been in contact with

- property any visitor known to have been exposed to COVID-19. See the COVID-19 Exclusion Summary Guide.
- Visitors/volunteers must wash or sanitize their hands upon entry and exit.
- Visitors/volunteers must maintain six-foot distancing, wear face coverings, and adhere to all other provisions of the *Ready Schools*, *Safe Learners* guidance.

anyone diagnosed with COVID 19. Question will be either asked by our office staff or will be asked with our electronic check-in.

- •Adult visitors may include parents/guardians for IEP Meetings, 504 Meetings, TAG or specific pre planned parent meeting with teacher/principal. These visitors will not be permitted in the classroom with students. Virtual meetings will be prioritized.
- Staff members such as student teachers, substitute teachers, counseling interns, practicum students, and other itinerant staff are not considered visitors.

Essential personnel/volunteers/visitors are required to:

- Wash or sanitize their hands upon entry and exit to the district's buildings.
- Be visually screened for symptoms during sign-in and will not be allowed to enter if symptomatic.
- Wear a face covering, maintain six feet of physical distance between themselves and others and adhere to all other provisions required by the district
- SCS will utilize "no touch" sign in for students, staff and visitors or if this can't be done then the sign in area will be disinfected in-between uses.
- SCS will have hand sanitizer and face coverings available for guests and visitors
- \bullet Front desk employee(s) will screen visitors for visual symptoms upon entry into the building

1h. FACE COVERINGS, FACE SHIELDS, AND CLEAR PLASTIC BARRIERS

OHA/ODE Requirements

- Employers are required to provide masks, face coverings, or face shields for all staff, contractors, other service providers, visitors and volunteers.
- Face coverings or face shields for all staff, contractors, other service providers, visitors or volunteers following CDC guidelines for Face Coverings. Individuals may remove their face coverings while working alone in private offices or when separated by more than 6 feet in outside learning spaces. Face shields are an acceptable alternative only when a person has a medical condition that prevents them from wearing a mask or face covering, when people need to see mouth and tongue motions in order to communicate, or when an individual is speaking to an audience for a short period of time and clear communication is otherwise not possible.
- Face coverings or face shields for all students in grades Kindergarten and up following <u>CDC guidelines for Face Coverings</u>. Face shields are an acceptable alternative when a student has a medical condition that prevents them from wearing a mask or face covering, or when people need to see the student's mouth and tongue motions in order to communicate.
- Face coverings should be worn both indoors and outdoors, including during outdoor recess.
- Group mask breaks" or "full classroom mask breaks" are not allowed. If a student removes a face covering, or demonstrates a need to remove the face covering for a short-period of time:
 - Provide space away from peers while the face covering is removed. In the classroom setting, an example could be a designated chair where a student can sit and take a 15 minute "sensory break;"
 - Students must not be left alone or unsupervised;
 - Designated area or chair must be appropriately distanced from other students and of a material

Hybrid/Onsite Plan

Face Shields and Barriers

- Face coverings or face shields will be provided for all SCS staff, contractors, other service providers, or visitors or volunteers following CDC guidelines Face Coverings. All staff, contractors, other service providers, or visitors or volunteers are expected to wear face coverings or face shields.
 - Face shields are an acceptable alternative when a person has a medical condition that prevents them from wearing a mask or face covering, when people need to see mouth and tongue motions in order to communicate, or when an individual is speaking to an audience for a short period of time and clear communication is otherwise not possible.
- All students in grades Kindergarten through Twelfth grade will wear face coverings or face shields following <u>CDC guidelines Face Coverings</u> at school, both indoors and outdoors.
 - Face shields are an acceptable alternative when a person has a medical condition that prevents them from wearing a mask or face covering or when people need to see mouth and tongue motions in order to communicate.
- If a student removes a face covering, or demonstrates a need to remove the face covering for a short-period of time, the teacher will:
 - Provide space away from peers while the face covering is removed; students should not be left alone or unsupervised.
 - Provide additional instructional supports to effectively wear a face covering;
 - Provide students adequate support to re-engage in safely wearing a face covering.
 - Students cannot be discriminated against or disciplined for an inability to safely wear a face covering during the school day.
- Students who abstain from wearing a face covering, or students whose families determine the student will not wear a face covering during On-Site instruction must be provided access to instruction.

- Provide additional instructional supports to effectively wear a face covering;
- Provide students adequate support to re-engage in safely wearing a face covering;
- Students cannot be discriminated against or disciplined for an inability to safely wear a face covering during the school day.
- □ Face masks for school RNs or other medical personnel when providing direct contact care and monitoring of staff/students displaying symptoms. School nurses shall also wear appropriate Personal Protective Equipment (PPE) for their role.
 - Additional guidance for nurses and health staff.

Accommodations under ADA or IDEA and providing FAPE while attending to Face Covering Guidance

- If any student requires an accommodation to meet the requirement for face coverings, districts and schools must limit the student's proximity to students and staff to the extent possible to minimize the possibility of exposure. Appropriate accommodations could include:
 - Offering different types of face coverings and face shields that may meet the needs of the student.
 - Spaces away from peers while the face covering is removed; students must not be left alone or unsupervised.
 - Short periods of the educational day that do not include wearing the face covering, while following the other health strategies to reduce the spread of disease.
 - Additional instructional supports to effectively wear a face covering.
- For students with existing medical conditions and a physician's orders to not wear face coverings, or other health related concerns, schools/districts must not deny any in-person instruction.
- Schools and districts must comply with the established IEP/504 plan prior to the closure of in-person instruction in March of 2020, or the current plan in effect for the student if appropriately developed after March of 2020.
 - If a student eligible for, or receiving services under a 504/IEP, cannot wear a face covering due to the nature of the disability, the school or district must:
 - Review the 504/IEP to ensure access to instruction in a manner comparable to what was originally established in the student's plan including on-site instruction with accommodations or adjustments.
 - Not make placement determinations solely on the inability to wear a face covering.
 - Include updates to accommodations and modifications to support students in plans.
 - For students protected under ADA/IDEA, who abstain from wearing a face covering, or students whose families determine the student will not wear a face covering, the school or district must:
 - Review the 504/IEP to ensure access to instruction in a manner comparable to what was originally established in the student's plan.
 - The team must determine that the disability is not prohibiting the student from meeting the requirement.
 - If the team determines that the disability is prohibiting the student from meeting the

Comprehensive Distance Learning may be an option; however, additional provisions apply to students protected under ADA and IDEA

• Our District Nurse or other medical personnel providing direct contact care and/or monitoring staff/students displaying symptoms are required to wear appropriate Personal Protective Equipment (PPE) for their role.

Protections under the ADA or IDEA

- If any student requires an accommodation to meet the requirement for face coverings, EPSD9 will work to limit the student's proximity to students and staff to the extent possible to minimize the possibility of exposure.
- For students with existing medical conditions, doctor's orders to not wear face coverings, or other health related concerns, EPSD9 will not deny access to On-Site instruction.
- SCS will comply with established IEP/504 plans.
- SCS will consider child find implications for students who are not currently eligible for, or receiving services under, a 504/IEP who demonstrate an inability to consistently wear a face covering or face shield as required. Ongoing inability to meet this requirement may be evidence of the need for an evaluation to determine eligibility for support under IDEA or Section 504.
- If a staff member requires an accommodation for the face covering or face shield requirements, SCS will limit the staff member's proximity to students and staff to the extent possible to minimize the possibility of exposure.

1i. ISOLATION AND QUARANTINE

OHA/ODE Requirements

- Protocols for exclusion and isolation for sick students and staff whether identified at the time of bus pick-up, arrival to school, or at any time during the school day.
- ☑ Protocols for screening students, as well as exclusion and isolation protocols for sick students and staff identified at the time of arrival or during the school day. See the COVID-19 Exclusion Summary Guide.
 - Work with school nurses, health care providers, or other staff with expertise to determine necessary modifications to areas where staff/students will be isolated. If two students present COVID-19 symptoms at the same time, they must be isolated at once. If separate rooms are not available, ensure that six feet distance is maintained. Do not assume they have the same illness. Consider if and where students and staff will be isolated during learning outside. Create a comfortable outdoor area for isolation or follow plan for in building isolation.
 - Consider required physical arrangements to reduce risk of disease transmission.
 - Plan for the needs of generally well students who need medication or routine treatment, as well as students who may show signs of illness.
 - Additional guidance for nurses and health staff for providing care to students with complex needs.
- Students and staff who report or develop symptoms must be isolated in a designated isolation area in the school or outside learning space, with adequate space and staff supervision and symptom monitoring by a school nurse, other school-based health care provider or school staff until they are able to go home. Anyone providing supervision and symptom monitoring must wear appropriate face covering or face shields.
 - School nurses and health staff in close contact with symptomatic individuals (less than 6 feet) must wear a

Hybrid/Onsite Plan

- The protocols for exclusion and isolation for sick students and staff whether identified at the time of bus pick-up, arrival to school, or at any time during the school day are available at SCS.
- SCS staff have been provided training on the signs of illness, guidelines for isolation, and appropriate measures to take, should a student or staff member display COVID-19 symptoms upon entry to school or at any time during the school day.
- A primary isolation area (CARE Room) will be designated for symptomatic staff and students at all sites. Supervision will be provided by the District Nurse or school personnel trained by the District Nurse. If necessary, secondary isolation areas (CARE Rooms) will be identified in collaboration with the District Nurse and site administrator.
- A separate designated area will be available for "well" students to access health care for routine first aid and medication administration. Symptomatic students will not have access to this area.

Exposed or Symptomatic Students and Staff

- Students and staff who report or develop symptoms will be isolated in a designated isolation area in the school, with adequate space and staff supervision and symptom monitoring by the District Nurse, other school-based health care provider or school staff until they are able to go home.
- Anyone providing supervision and symptom monitoring must wear appropriate face covering or face shields.
 - School nurses and health staff in close contact with symptomatic individuals (less than six feet) should wear a medical-grade face mask. Other Personal Protective Equipment (PPE) may be needed depending on symptoms and care provided. Any PPE used during care of a symptomatic individual should be properly removed and disposed of prior to exiting the care space.

- medical-grade face mask. Other Personal Protective Equipment (PPE) may be needed depending on symptoms and care provided. Consult a nurse or health care professional regarding appropriate use of PPE. Any PPE used during care of a symptomatic individual must be properly removed and disposed of prior to exiting the care space.
- After removing PPE, hands shall be immediately cleaned with soap and water for at least 20 seconds. If soap and water are not available, hands can be cleaned with an alcohol-based hand sanitizer that contains 60-95% alcohol.
- If able to do so safely, a symptomatic individual shall wear a face covering.
- To reduce fear, anxiety, or shame related to isolation, provide a clear explanation of procedures, including use of PPE and handwashing.
- Establish procedures for safely transporting anyone who is sick to their home or to a health care facility.
- Staff and students who are ill must stay home from school and must be sent home if they become ill at school, particularly if they have COVID-19 symptoms. Refer to table in "Planning for COVID-19 Scenarios in Schools."
- ☑ Involve school nurses, School Based Health Centers, or staff with related experience (Occupational or Physical Therapists) in development of protocols and assessment of symptoms (where staffing exists).
- Record and monitor the students and staff being isolated or sent home for the LPHA review.
- The school must provide a remote learning option for students who are required to be temporarily off-site for isolation and quarantine.

Hybrid/Onsite Plan

- After removing PPE, hands should be immediately cleaned with soap and water for at least 20 seconds. If soap and water are not available, hands can be cleaned with an alcohol-based hand sanitizer that contains 60-95% alcohol.
- If able to do so safely, any symptomatic individual should continue to wear a face covering.
- To reduce fear, anxiety, or shame related to isolation, a clear explanation of procedures, including use of PPE and handwashing will be provided to exposed or symptomatic students and staff.
- The Administrator or designee at the location of students or staff that have been exposed or are symptomatic will contact parent/guardian or significant other to transport the student or staff member home. If necessary, transportation by bus can be made.
- Staff and students who are ill must stay home from school and must be sent home if they become ill at school, particularly if they have COVID-19 symptoms.
- Symptomatic staff or students should be evaluated and seek COVID-19 testing from their regular physician or through the local public health authority. They must remain home following our district's COVID 19 Illness Protocol or doctor recommendation.
- SCS will record and monitor the students and staff being isolated or sent home for the LHA review.
- All teachers will continue to use Canvas (LMS) to post their classroom activities/assignments. This will allow for students who are temporarily isolated and quarantined to access assignments. This will allow SCS to provide a remote learning option for students who are required to be temporarily off-site for isolation and quarantine.



2. Facilities and School Operations

Some activities and areas will have a higher risk for spread (e.g., band, choir, science labs, locker rooms). When engaging in these activities within the school setting, schools will need to consider additional physical distancing or conduct the activities outside (where feasible). Additionally, schools should consider sharing explicit risk statements for instructional and extra-curricular activities requiring additional considerations (see section 5f of the *Ready Schools, Safe Learners* guidance).

2a. ENROLLMENT

(Note: Section 2a does not apply to private schools.)

OHA/ODE Requirements

- The temporary suspension of the 10-day drop rule does not change the rules for the initial enrollment date for students:
 - The ADM enrollment date for a student is the first day of the student's actual attendance.
 - A student with fewer than 10 days of absence at the beginning of the school year may be counted in membership prior to the first day of attendance, but not prior to the first calendar day of the school year.
 - If a student does not attend during the first 10 session days of school, the student's ADM enrollment date must reflect the student's actual first day of attendance.

Hybrid/Onsite Plan

All students will be enrolled following the Oregon Department of Education guidelines.

- Students and families will be given the option to enroll in On-site, Hybrid learning or off-site/online only learning based on parent choice
- Hybrid learning and off-site only learning opportunities will utilize parallel planning, allowing symptomatic students to continue learning during a medical absence.

No student will be dropped for non-attendance if they meet the following conditions:

• Are identified as vulnerable, or otherwise considered to be a part of a population vulnerable to infection with COVID-19.

- Students who were anticipated to be enrolled, but who do not attend at any time must not be enrolled and submitted in ADM.
- ☑ If a student has stopped attending for 10 or more days, districts must continue to try to engage the student. 2b. ATTENDANCE

(Note: Section 2b does not apply to private schools.)

OHA/ODE Requirements

- Grades K-5 (self-contained): Attendance must be taken at least once per day for all students enrolled in school, regardless of the instructional model (On-Site, Hybrid, Comprehensive Distance Learning, online schools).

Handwashing:

2g. PLAYGROUNDS, FIELDS, RECESS, BREAKS, AND RESTROOMS

- Keep school playgrounds closed to the general public until park playground equipment and benches reopen in the community (see Oregon Health Authority's <u>Specific Guidance for Outdoor</u> <u>Recreation Organizations</u>).
- After using the restroom students must wash hands with soap and water for 20 seconds. Soap must be made available to students and staff. For learning outside if portable bathrooms are used, set up portable hand washing stations and create a regular cleaning schedule.
- Before and after using playground equipment, students must wash hands with soap and water for 20 seconds <u>or</u> use an alcohol-based hand sanitizer with 60-95% alcohol.
- Designate playground and shared equipment solely for the use of one cohort at a time. Outdoor playground structures require normal routine cleaning and do not require disinfection. Shared equipment (balls, jump ropes, etc.) should be cleaned and disinfected at least daily in accordance with CDC guidance.
- Cleaning requirements must be maintained (see section 2j of the Ready Schools, Safe Learners guidance).
- Maintain physical distancing requirements, stable cohorts, and square footage requirements.
- Provide signage and restrict access to outdoor equipment (including sports equipment, etc.).
- Design recess activities that allow for physical distancing and maintenance of stable cohorts.
- Clean all outdoor equipment at least daily or between use as much as possible in accordance with <u>CDC guidance</u>.
- Limit the number of employees gathering in shared spaces.

 Restrict use of shared spaces such as conference rooms, break rooms, and elevators by limiting occupancy or staggering use, maintaining six feet of distance between adults. Establish a minimum of 35 square feet per person when determining room capacity. Calculate only with usable space, understanding that tables and room set-up will require use of all space in the calculation. Note: The largest area of risk is adults eating together in break rooms without face coverings.

Hybrid/Onsite Plan

- Playground(s) will remain closed for public use. Schools will post adequate signs sharing this information with the public. At that point, classes may use the playground for recess on a staggered schedule throughout the school day.
- Playground supplies: Each cohort group will use their own playground supplies (e.g., balls, jump ropes, etc.) and cleaned daily.
- After using the restroom, students will wash hands with soap and water for 20 seconds. Soap is available to students and staff.
- Before and after using playground equipment, students will wash hands with soap and water for 20 seconds <u>or</u> use an alcohol-based hand sanitizer with 60-95% alcohol.
- Cleaning requirements will be maintained.
- Recess activities will be planned to support physical distancing and maintain stable cohorts. This can include limiting the number of students on one piece of equipment, at one game, etc.
- Given the lessened capacity for equipment use due to cohorting and physical distancing requirements, staff will set expectations for shared use of equipment by students and may need to support students with schedules for when specific equipment can be used. Each cohort will have their own equipment bag and equipment will be sanitized daily.
- Staff rooms, common staff lunch areas, and workspaces will be limited to 35 sq ft per person, maintaining six feet of distance between adults.

2h. MEAL SERVICE/NUTRITION

OHA/ODE Requirements

- ☐ Include meal services/nutrition staff in planning for school reentry.
- Prohibit self-service buffet-style meals.
- ☑ Prohibit sharing of food and drinks among students and/or staff.
- At designated meal or snack times, students may remove their face coverings to eat or drink but must maintain six feet of physical distance from others, and must put face coverings back on after finishing the meal or snack.
- Staff serving meals and students interacting with staff at mealtimes must wear face coverings (see section 1h of the *Ready Schools, Safe Learners* guidance). Staff must maintain 6 feet of physical distance to the greatest extent possible. If students are eating in a classroom, staff may supervise from the doorway of the classroom if feasible.
- Students and staff must wash hands with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol before meals and shall be encouraged to do so after.
- Appropriate daily cleaning of meal items (e.g., plates, utensils, transport items).
- Cleaning and sanitizing of meal touch-points and meal counting system between stable cohorts.
- Adequate cleaning and disinfection of tables between meal periods.
- Since staff must remove their face coverings during eating and drinking, limit the number of employees gathering in shared spaces. Restrict use of shared spaces such as conference rooms and break rooms by limiting occupancy or staggering use. Consider staggering times for staff breaks, to prevent congregation in shared spaces. Always maintain at least six feet of physical distancing and establish a minimum of 35 square feet per person when determining room capacity. Calculate only with usable classroom space, understanding that desks and room set-up will require use of all space in the calculation. Wear face coverings except when eating or drinking and minimize time in spaces where face coverings are not consistently worn.

Hybrid/Onsite Plan

- Sodexo and Eagle Point School District 9 will continue to provide meal service to students on-site (and off-site to the extent possible) and in compliance with Federal requirements for meals.
- Health and safety standard protocols will be followed by staff.
- Cleaning and disinfecting of facilities will align with CDC Cleaning and Disinfecting School Guidance.
- Face coverings and gloves will be required for Food and Nutrition Services workers and other staff at all times when serving food and cleaning or sanitizing an item or surface.
- Each table/desk will be cleaned prior to meals being consumed.
- All students must wash or sanitize hands prior to meals and should be encouraged to do so after. If possible, this should be done in the classroom. If not, student hand sanitizer is available in the cafeteria.
- Students will eat breakfast in their classroom and snack either in their classroom or outside. Students will eat lunch in the cafeteria or gym with their cohort groups. Staff will maintain 6 feet of physical distance to the greatest extent possible.
- Physical distancing requirements will be maintained in transit.
- If students pick up food, touchpoints in the cafeteria will be sanitized between stable cohorts.
- Transported trays/carts will be sanitized between deliveries to stable cohorts.
- Students will not share food, utensils, or other items during meals.
- Since staff must remove their face coverings during eating and drinking, staff will eat in their room, outside picnic tables or in the common staff lunch area and will be limited to 35 sq ft per person, maintaining six feet of distance between adults.

2i. TRANSPORTATION

OHA/ODE Requirements

- ☐ Include transportation departments (and associated contracted providers, if used) in planning for return to service.
- Buses are cleaned frequently. Conduct targeted cleanings between routes, with a focus on disinfecting frequently touched surfaces of the bus (see section 2j of the *Ready Schools, Safe Learners* guidance).
- Staff must use hand sanitizer (containing between 60-95% alcohol) in between helping each child and when getting on and off the vehicle. Gloves are not recommended; hand sanitizer is strongly preferred. If hand sanitizer is not available, disposable gloves can be used and must be changed to a new pair before helping each child.
- Develop protocol for loading/unloading that includes visual screening for students exhibiting symptoms and logs for contacttracing. This must be done at the time of arrival and departure.
 - If a student displays COVID-19 symptoms, provide a face covering (unless they are already wearing one) and keep six feet away from others. Continue transporting the student.
 - The symptomatic student shall be seated in the first row of the bus during transportation, and multiple windows must be opened to allow for fresh air circulation, if feasible.

Hybrid/Onsite Plan

This plan has been created in conjunction with our EPSD9 Transportation team.

Bus drivers are required to wear masks or face coverings when not actively driving and operating the bus, including while students are entering or exiting the vehicle. A face shield may be an acceptable alternative, as stated in Section 1h of the *Ready Schools, Safe Learners* guidance.

Each bus driver/staff will be required to:

- Follow entry and screening procedures (training will be provided by the District).
- Remind all students in grades Kindergarten and up to follow CDC guidelines by wearing face coverings or face shields.
- •Staff must use hand sanitizer (containing between 60-95% alcohol) or new gloves in between helping each child and when getting on and off the vehicle.
- Visually screen students for illness.
 - If a student displays COVID-19 symptoms, provide a face shield or face covering (unless they are already wearing one) and keep six feet away from others.
 - Continue transporting the student.
 - If arriving at school, notify staff to begin isolation measures.

- The symptomatic student shall leave the bus first.
 After all students exit the bus, the seat and surrounding surfaces must be cleaned and disinfected.
- If arriving at school, notify staff to begin isolation measures.
 - o If transporting for dismissal and the student displays an onset of symptoms, notify the school.
- Consult with parents/guardians of students who may require additional support (e.g., students who experience a disability and require specialized transportation as a related service) to appropriately provide service.
- Drivers must wear masks or face coverings while driving, unless the mask or face covering interferes with the driver's vision (e.g., fogging of eyeglasses). Drivers must wear face coverings when not actively driving and operating the bus, including while students are entering or exiting the vehicle. A face shield may be an acceptable alternative, only as stated in Section 1h of the *Ready Schools, Safe Learners* guidance.
- Inform parents/guardians of practical changes to transportation service (i.e., physical distancing at bus stops and while loading/unloading, potential for increased route time due to additional precautions, sanitizing practices, and face coverings).
- Face coverings for all students, applying the guidance in section 1h of the *Ready Schools, Safe Learners* guidance to transportation settings. This prevents eating while on the bus.
- Take all possible actions to maximize ventilation: Dress warmly, keep vents and windows open to the greatest extent possible.

Hybrid/Onsite Plan

- If transporting for dismissal and the student displays an onset of symptoms, the driver will notify the school office.
- Consult with parents/guardians of students who may require additional support (e.g., students who experience a disability and require specialized transportation as a related service) to appropriately provide service.
- Inform parents/guardians of practical changes to transportation service (i.e., physical distancing at bus stops and while loading/unloading, potential for increased route time due to additional precautions, sanitizing practices, and face coverings)
- Clean and sanitize buses on a regular basis and as directed with the product used. Targeted cleanings of frequently touched surfaces of the bus (see section 2j).
- Busses will keep vents and windows open to the greatest extent possible.

2j. CLEANING, DISINFECTION, AND VENTILATION

OHA/ODE Requirements

- Clean, sanitize, and disinfect frequently touched surfaces (e.g. door handles, sink handles, drinking fountains, transport vehicles) and shared objects (e.g., toys, games, art supplies) between uses multiple times per day. Maintain clean and disinfected (CDC guidance) environments, including classrooms, cafeteria settings and restrooms. Provide time and supplies for the cleaning and disinfecting of high-touch surfaces between multiple student uses, even in the same cohort.
- Outdoor learning spaces must have at least 75% of the square footage of its sides open for airflow.
- Outdoor playground structures require normal routine cleaning and do not require disinfection. Shared equipment should be cleaned and disinfected at least daily in accordance with <u>CDC</u> guidance.
- Apply disinfectants safely and correctly following labeling direction as specified by the manufacturer. Keep these products away from students.
- To reduce the risk of asthma, choose disinfectant products on the EPA List N with asthma-safer ingredients (e.g. hydrogen peroxide, citric acid, or lactic acid) and avoid products that mix these with asthma-causing ingredients like peroxyacetic acid, sodium hypochlorite (bleach), or quaternary ammonium compounds.
- Schools with HVAC systems must evaluate the system to minimize indoor air recirculation (thus maximizing fresh outdoor air) to the extent possible. Schools that do not have mechanical ventilation systems shall, to the extent possible, increase natural ventilation by opening windows and interior doors before students arrive and after students leave, and while students are present. Do not prop open doors that can pose a safety or security risk to students and staff (e.g., exterior doors and fire doors that must remain closed.)

Hybrid/Onsite Plan

All frequently touched surfaces (e.g. door handles, sink handles, drinking fountains, transport vehicles) and shared objects (e.g., toys, games, art supplies) will be cleaned between uses at least multiple times per day with ALHA HP or Virex. There has been time provided during the day and between cohorts for staff to clean/disinfect.

Each cohort group will use their own playground equipment (e.g., balls, jump ropes, etc.) and be disinfected at least daily.

Outdoor playground structures require normal routine cleaning and do not require disinfection.

If an outdoor learning space is used there will be at least 75% of the square footage open to airflow.

Disinfectants will be applied safely and correctly following labeling direction as specified by the manufacturer. These products will be kept away from students.

To reduce the risk of asthma, disinfectant products on the EPA List N with asthma-safer ingredients (e.g. hydrogen peroxide, citric acid, or lactic acid) and avoid products that mix these with asthma-causing ingredients like peroxyacetic acid, sodium hypochlorite (bleach), or quaternary ammonium compounds have been chosen.

Operations of Outside Air

• Minimum of 5% open during unoccupied or when temperature is too high or too low. All of the OSA setups are per ASHRAE standards for building size and occupancy level and our regional zone. In our newer schools we have digital controls to set and monitor outside air

- Schools with HVAC systems should ensure all filters are maintained and replaced as necessary to ensure proper functioning of the system.
- All intake ports that provide outside air to the HVAC system should be cleaned, maintained, and cleared of any debris that may affect the function and performance of the ventilation system.
- Consider running ventilation systems continuously and changing the filters more frequently. Do <u>not</u> use fans if they pose a safety or health risk, such as increasing exposure to pollen/allergies or exacerbating asthma symptoms. - Facilities must be cleaned and disinfected at least daily to prevent transmission of the virus from surfaces (see <u>CDC's guidance on</u> <u>disinfecting public spaces</u>).
- Consider modification or enhancement of building ventilation where feasible (see <u>CDC's guidance on ventilation and filtration</u> and <u>American Society of Heating, Refrigerating, and Air-Conditioning Engineers' guidance</u>).
